Real Estate Private Equity 房地产私募股权

We invest in properties using different strategies: Conservatively invested in low-risk rental properties offering stable, predictable income, and other funds invest in land or speculative development deals, which offer high return potential and greater risk.

Infrastructure 基础设施

Funds raises capital from investors, acts as an investor and buys into a portfolio of other private equity funds.

Distressed Private Equity 困境私募股权基金

Specialize in lending to companies in financial crises. The purpose is to take control of the business during the bankruptcy or restructuring processes so they can buy the company at a lower purchase price, then we'll work to turn the companies around and sell them.

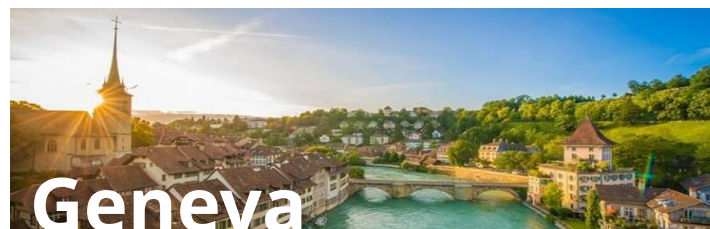
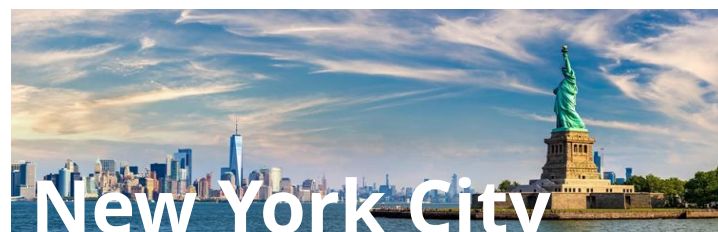
